

Letter From the President - RJ Ringa

Long Lake Improvement and Sanitation Association (LLISA) has several projects in motion and is always in need of volunteers. While membership is critical to the success of our organization, please consider ways you might be able to contribute time or expertise to support Long Lake. Here are some highlights of current projects.

Baxter's NPDES Permit

Baxter's waste water treatment plant at their Round Lake facility continues to be a significant ecological concern to Long Lake. Over the last 40 years, the IEPA has granted Baxter a National Pollutant Discharge Elimination System (NPDES permit to dump their treated wastewater into the Squaw Creek watershed that flows directly into Long Lake.

The IEPA has issued Baxter numerous permit violations over the years. Newer violations charge that Baxter's wastewater exceeded pollutant levels regulated by the IEPA. We took action in the summer of 2016 when LLISA and Long Lake residents wrote letters to the IEPA and worked with local and state government officials to voice our concern. LLISA representatives also met with Baxter in the fall of 2016 to voice our concerns directly. Since that time, Baxter has met with Lakes Region Sanitary District, Fox Lake, Round Lake and Lake County to investigate a public sewer connection, but the process is slow and Baxter has not yet committed to a connection.

LLISA has publicly stated that Baxter must connect to the public sewer. Since Baxter's NPDES permit is up for renewal in 2018, this is a critical time to make our message heard. For more information and to learn how you can help see the Baxter article inside.

Phosphorus/Bluegreen algae - Sierra Club

Long Lake also has internal environmental concerns. High levels of phosphorus lead to blue-green algae, a potentially toxic organism that threatens public health, lake ecosystems, and the recreational value of our waters.

While blue-green algae was less prevalent in 2016 as compared to 2015, the lake still experienced significant blooms in the late summer/fall. In response, LLISA has partnered with the local branch of Sierra Club and participated in several collaborative meetings over the winter. We are very excited to have the support of Sierra Club and the resources they bring. Lake Management Plan

While there are a variety of government organizations tasked with oversight and environmental conservation of Long Lake, we do not have a coordinated strategy to address lake specific management issues. It is up to us, as homeowners and residents, to take the lead on coordinating these efforts. Therefore LLISA is initiating a committee to write our own lake management plan.

A lake management plan is a dynamic document that can encompass anything from a plan to control an invasive species to watershed management. Our lake management plan will provide a framework for current and future LLISA boards to identify priorities, establish potential solutions, and document the success of prior efforts.

LLISA is committed to writing a lake management plan specific to our needs and concerns. Baxter's NPDES Permit

Since 1975, the Illinois EPA has granted Baxter a National Pollutant Discharge Elimination System (NPDES) permit to dump treated wastewater into the watershed that flows directly into Long Lake. The wastewater originates as human sanitary waste, industrial waste, and storm sewer drainage. In 2016, Baxter discharged an average of 278,000 gallons of wastewater every day, equal to the waste discharge of nearly 800 homes. Additionally, Baxter's waste is largely industrial which magnifies the potential impact on the environment.

In 2016, Baxter incurred 2 IEPA violations for exceeding pollutant limits in their waste water. Further, Baxter has had numerous violations over the years (see chart) and the IEPA has not levied any fines and continues to grant them permits to dump wastewater into Long Lake's watershed. Also in 2016, the Illinois Pollution Control Board started an investigation into Baxter's wastewater discharge practices which is currently ongoing.

LLISA stands firm with lake residents, homeowners, and other organizations such as Stop Pollution in Long Lake that Baxter must connect to the public sewer. Since Baxter's NPDES permit is up for renewal in 2018, this is a critical time to make our message heard.

Long Lake - Volunteer Lake Monitoring Program


RJ Ringa will spend another year collecting data for the Volunteer Lake Monitoring Program (VLMP). For the first time, this includes all three tiers of the national lake monitoring program: tier 1 – water clarity, tier 2 – water chemistry, and tier 3 dissolved oxygen and chlorophyll. We are very fortunate to have this opportunity; this year, tier 3 is available to only 4 lakes in the entire state. Tier 3 is more labor intensive, but also provides higher quality data, especially important given recent blue-green algae blooms that occur on Long Lake.

Tier 3 collects:

- 1. A bottom water sample in addition to a surface sample.
- 2. Chlorophyll samples at three sites.
- 3. Dissolved oxygen profiles at 3 sites

Data is collected from May through October and is submitted to the IEPA in Springfield. This data is then used to inform lake management decisions and can help us better understand the environmental health of our waters.

The chart to the right shows VLMP water clarity going back to 1994. Of particular note from 2016 is the record 148 inches of water clarity observed in spring 2016.



That is over 12 feet. Greatest clarity is typically found in the spring. Water clarity tends to decrease in the summer as warmer weather and increased sunshine promotes algae growth and increased boat traffic leads to greater turbidity.

To prevent injury to people and damage to the hoists, the following rules MUST be followed:

- 3500 lbs max weight, 1850 lbs max concentrated load on either hoist
- 102" max beam
- All people must exit the boat and use extreme caution when operating the hoists

Fishing Hole News



LLISA's fish stocking plan continues to be the same with 250 walleye, 43 northern pike and 20 pure musky being stocked in fall 2016. The stocking is done with recommendations from the Illinois Department of Natural Resources and Richmond Fisheries for a lake of our size and structure. Medium to large size fingerlings are stocked due to their better survival rates and the goal of providing a better fishery.

The most recent Illinois DNR Fish Survey conducted in May of 2016 shows a successful trend in predator / prey relationships, with 73 largemouth bass caught in 60 minutes of electrofishing for a catch rate of 1.2 fish per minute. The goal is 1 bass per minute. Furthermore, the quality of bass collected was good and suffi-

cient predation is present in the lake to balance high reproducing forage species.

Forty- five of the bass collected were at least 12" long and sexually mature and data shows the largemouth bass is not experiencing significant harvest. 220 fish and fifteen different species were caught in the one hour of electrofishing.

The IDNR fish study team was so pleased with the study that they planned on coming back out to Long Lake over the summer months to spend more time with their friends and family fishing! We cannot stress the importance of following the Illinois DNR creel and size limits. Please practice catch and release on Long Lake!

Additional fish fund donations are being made locally from Pickerel Point Association Members. Thank you for keeping our lake stocked. We will continue our local fish fund donation program and are open to suggestions.

Sierra Club Comes to Long Lake

Many thanks go out to Gloria Charland, a longtime resident and LLISA member, who is on the executive committee of the local Woods and Wetlands Chapter of the Illinois Sierra Club.

After experiencing Long Lake's struggles with blue-green algae Mrs. Charland worked to connect LLISA and Sierra Club to further investigate the causes and solutions to our most pressing environmental concern: elevated phosphorus and associated blue-green algae blooms. Sierra Club is one of the largest and most influential environmental groups to focus on local and national issues. Sierra Club's stated goal to explore, enjoy and protect the planet is in line with LLISA's and we are proud to have them as an ally.

Sierra Club's Evan Craig (chairman), Jim Bland (water quality biologist), and Cindy Skukrud (Clean Water Program Director) have spent many hours learning about Long Lake, meeting with LLISA, and advo-



cating on our behalf to local and state government agencies, including the IEPA. LLISA has benefited from Sierra Club's expertise in public policy, lake biology, and grant funding sources.
